All that piece or parcel of land, which is a 4 foot strip along the front of Lot No. 6, as shown on Plat of University Park, by Dalton E. Heves, dated November 1946 and recorded in the R. M. C. Office for Greenville County in Plat Book "P" at Page 127, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Stephens Lane, joint front corner of Lots 6 and 7, and running thence along line of Lots 6 and 7 N. 37-34 W. 4 feet to an iron pin; thence N. 52-26 E. 79.2 feet to an iron pin; thence along Stephens Lane S. 7-26 W. 5.8 feet to an iron pin; thence S. 52-26 W. 75 feet to the beginning corner.
