Know All Men by These Presents:

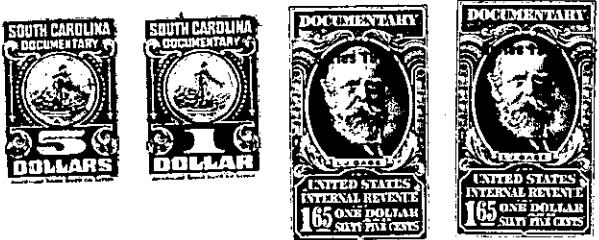

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said L. O. Baker and Jessey S. Baker, their heirs and assigns forever:

All that lot of land in Bates Township, Greenville County, State of South Carolina, on the eastern side of U. S. Highway 276, sometimes called Cleveland Avenue, in the town of Marietta, being a portion of Block 2 as shown on plat of property of J. Norwood and Estate of R. Mays Cleveland made by W. M. Rast in December, 1927, recorded in Plat Book BB at pages 62-63, and also shown as Lot 2 on a plat made by C. O. Riddle in May, 1954, and described as follows:

BEGINNING at a stake on the eastern side of U. S. Highway 276 225 feet south from Slater Street at corner of Lot 1 and running thence with the line of said lot S. 67-40 E. 150 feet to a stake; thence S. 22-20 W. 125 feet to a stake at corner of Lot 3; thence with the line of said lot N. 67-40 W. 150 feet to a stake on U. S. Highway 276; thence with the eastern side of said highway N. 22-20 E. 125 feet to the beginning corner, being the same property conveyed to grantors by deed recorded in Deed Book 396, Page 196.
