

All that lot of land partly within and partly without the incorporate limits of the city of Greenville, in the county of Greenville, state of South Caroline, being known and designated as lot No. 24 on plat of property of Donald E. Beltz recorded in plat book Y page 46 of the R. M. C. Office for Greenville County and having according to a recent survey made August 1954 by A. W. Dalton, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeasterly side of Sharon prive, joint front corner of lots Nos. 24 and 25, and running thence with the foint 1 ne of said lots N. 32-07 E. 150 feet to an iron pin corner of lob to. 15; the country the rear line of said lot S. 57-53 E. 75 feet to an iro pin corner of lot a. 23; thence with the line of said lot S. 52-07 ... 150 feet to an iron in on the northeasterly side of Sharon Drive; thence with the northeasterly side of said Street N. 57-53 W. 75 feet to the beginning corner.

This lot shall be used for residential purposes only, and only one single family residence shall be erected thereon. To trailer, garage or other outbuilding shall be used for living quarters.
