to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto JUNIUS H. GARRISON:

All our right, title and interest, the same being an undivided one-third interest in and to

All that piece, parcel or lot of land in Grove Township, Greenville County, State of South Carolina, containing 141 acres, more or less, and known as the Jarrett Yeargin land and bounded by lands now or formerly of Miss J. A. Huff, Jackson, Hill, Henry Stokes and others and more particularly described in a deed to Jarrett Yeargin by William Blassingame, Sheriff, in 1835 and recorded in the R. M. C. Office for Greenville County in Deed Book S, at page 5, and being the same tract of land conveyed to Velona Garrison by Margaret Yeargin, et al, by deed dated November, 1895, and recorded in Deed Book BBB, at page 520.

The said Velona Garrison died intestate in 1904 and left surviving as her only heirs-at-law her husband, H. S. Garrison, and three children, Junius H. Garrison (the grantee herein), Mary G. McNutt and Mabel G. Benson. By deed dated February 20, 1939, and recorded in the R. M. C. Office for Greenville County in Deed Book 209, at page 126, the said H. S. Garrison conveyed all his right, title and interest in the above described property to his children the said Junius H. Garrison, Mary G. McNutt and Mabel G. Benson.

The said Mary G. McNutt died intestate at Baton Rouge, Louisiana, in May, 1954, leaving as her only heirs-at-law the grantors herein, the said George E. McNutt being her husband and the said George E. McNutt, Jr. and Shirley McNutt Boyce, being her only children.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantor(s) hereinabove named, his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantors, and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
