'All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, located about five miles North from Greer and on the East side of State Highway No. 101(also known as Rutherfordton Road), just North from South Tyger River, bounded on the North by lands of the Arsel Stone Estate, on the East by lands now or formerly of the S.D. McAbee Estate, on the South by lands of Mrs. R.W. Bridwell, and on the East by said highway, having the following courses and distances: BEGINNING at a point in the center of said State Highway, corner with Ers. R.W.
