Mull, ALICE FARNSWORTH in the State aforesaid, to consideration of the sum of Seven Thousand Six Hundred Thirty-Nine and 30/100 DOLLARS, and the assumption of the mortgage indebtedness set forth below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Alvin F. Batson, his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on the eastern side of U.S. Highway No. 25 (Buncombe Rd) near the City of Greenville, and being shown as lots 3 and 4, on plat of property of J. S. Fox, by Piedmont Engineering Service, in April 1949, recorded in Plat Book V. at page 169, and described as follows:

Beginning at a stake on the eastern side of Buncombe Road, 100 feet South of an unnamed street, at corner of lot 5, and running thence with the eastern side of said road, S 15-10 E, 100 feet to a stake; thence continuing with said road, S 13-21 E, 100 feet to a stake at corner of lot 2; thence with the line of said lot, N 68-00 E, 202.9 feet to a stake; thence N 16-13 E, 202.4 feet to a stake at corner of lot 5; thence with the line of said lot, S 68-00 W, 197.6 feet to the beginning.
