KNOW All Men by These Presents, That we, Douglas V. Killingsworth, Wiley S. Killingsworth, Laurens H. Killingsworth, Alice Vance Barton, William B. K. Vance, Fay Dobbs McCord, Griffie D. Sullivan, Frank G. Vance, Caroline V. Cunningham, Marie E. Hinton, Amy E. Sloan, Martha R. Vance and Lillie V. Ferguson, heirs at law of Laurie Vance Norwood, deceased, in consideration of the sum of TWENTY FIVE THOUSAND (\$25,000.00) DOLLARS, to the grantors in hand paid at and before the sealing of these presents by the grantee (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto

The Most Reverend John J. Russell, as the Bishop of Charleston, a Corporation Sole under the Laws of the State of South Carolina, and his successors in the Episcopal See of Charleston according to the discipline and government of the Roman Catholic Church, and his and their assigns forever,

All that certain piece, parcel, lot or tract of land lying, situate and being in Ward One, City of Greenville, State and County aforesaid, and known and designated as a portion of lots Nos. 6, 7, 8 and 9 of a sub-division of Morwood Property, according to plat made by W. D. Neves, Engineer, May 24, 1920, and having the following metes and bounds:

REGINNING at an iron pin on the alleyway at joint corner of lots 5 and 6 and running thence parallel with West Washington St. 100 feet to iron pin on line of Catholic Church property; thence along line of Catholic Church property 247 feet, more or less, to iron pin corner; thence along line of the Charles Estate to an iron pin in said alleyway 100 feet, more or less; thence along said alleyway 249.9 feet, more or less, to beginning, SAVING AND EXCEPTING therefrom a 19 ft. strip heretofore conveyed by W. M. Norwood to the City of Greenville for street purposes by deed dated June 12, 1924 and recorded in Deed Book 83 at Page 263, R. M. C. Office for Greenville County, South Carolina.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee hereinabove named, his successors and assigns.
