All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located on the northwest side of the Hammett Bridge Road and about two miles southwest of the City of Greer, known and designated as Lot No. 5 on a plat of property made for J.H. Greer by W.P. Morrow, Surveyor, dated July 2, 1955, and having the following courses and distances: BEGINNING at a point in the Hammett Bridge Road, joint corner of Lots Nos. 5 and 6 (iron pin on bank of the road), and runs thence with the common line of these lots N. 44.30 W. 200 feet to an iron pin; thence N. 42.24 E. 100 feet to an iron pin, joint rear corner of Lots Nos. 4 and 5; thence with the common line Lots Nos. 4 and 5 S. 44.30 E. 200 feet to a point in the said road(iron pin on bank thereof); thence with said road S. 42.24 W. 100 feet to the beginning corner. As a part of the consideration for this deed, the above described lot is conveyed subject to the following restrictions: This property shall be used for residential purposes only, and no dwelling shall be erected on said lot with less that 1150 square feet of floor space and valued at not less than \$9,000.00. A sceptic tank shall be required for each dwelling and no outbuildings shall be erected, except a garage. No livestock shall be kept upon the premises. These restrictions are for the benefit of the grantor herein and his heirs and devisees, and also for the benefit of any others who may purchase lots in this subdivision, and should there be a violation of any of these restrictions any of said persons may seek injunctive relief and damages.
