All that parcel, piece or lot of land with the buildings and improvements thereon, situate, lying and being on the northwest side of West Hillcrest Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as lot 57, on plat of Druid Hills, made by Dalton & Neves, Engineers, January, 1947, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book P, at page 113, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwest side of West Hillcrest Drive; joint front corner of lots 56 and 57, said pin being 913.3 feet in a westerly and southerly direction from the northwest corner of the intersection of West Hillcrest Drive and West Fairview Avenue, and running thence with the line of lot 56, N 63-10 W, 137.5 feet to an iron pin; thence S 00-30 E, 145.9 feet to an iron pin on the northwest side of West Hillcrest Drive; thence with the northwest side of West Hillcrest Drive, N 66-30 E, 50.5 feet to an iron pin; thence continuing with West Hillcrest Drive, N 35-00 E, 50 feet to an iron pin; thence continuing with West Hillcrest Drive, N 51-00 E, 50 feet to the beginning corner.

This being the same property conveyed the grantor by deed book 423 at page 32.

The grantee assumes and agrees to pay the balance due on that note and mortgage to C. Douglas Wilson & Co. as of November 1, 1955 in sum of \$5,020.53, which mortgage is recorded in the R.M.C. Office for Greenville County in Mortgage Book 370 at page 194.
