to the grantor(s) in hand paid at and before the sealing of these presents by the grantees (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Leon H. Robinson, his heirs and assigns forever:

All that certain piece, parcel or lot of land lying and being on the westerly side of Timberlake Drive, near the City of Greenville, S. C., being shown as Lot No. 44 on the plat of Timberlake as recorded in the RMC Office for Greenville County, S. C. in Plat Book "EB", page 185, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Timberlake Drive at a point 280 feet north of the northwesterly corner of the intersection of Timberlake Drive and Spartanburg Road, said pin being the joint front corner of Lots Nos. 44 and 45, and running thence along the westerly side of Timberlake Drive N 7-40 E 90 feet to an iron pin, joint front corner of Lots Nos. 43 and 44; thence along the joint line of said Lots N 82-20 W 206.5 feet to an iron pin in the line of Lot No. 25; thence S 2-03 W 90.5 feet to an iron pin in the line of Lot No. 24, joint rear corner of Lots Nos. 44 and 45; thence along the joint line of said Lots S 82-20 E 197.7 feet to the point of beginning.
