R. W. MANLEY, his heirs and assigns forever,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as a portion of Lot No. 8 as shown on plat recorded in Plat Book "M", at page 27, RMC Office for Greenville County and more accurately described on plat of property of C. J. Moody made May 30, 1955 by C. C. Jones, and having, according to said plat, the following metes and bounds, to wit:
