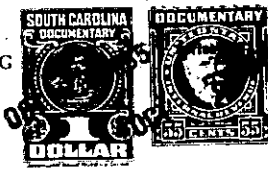

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

J. T. LORD and ANNA LORD, their heirs and assigns, forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 47 of Wynette Estates, a subdivision of the M. W. Fore property, located approximately 2.4 miles South of Gantt Station in Greenville County, South Carolina, made by Pickell & Pickell, Engineers, dated May 26, 1953, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Wyoming Avenue at joint front corners of Lots No. 47 and 48 and running thence along the line of said Lot No. 48, S. 89-04 E. 180 feet to iron pin at back corner of Lot No. 60; thence along the rear line of said Lot No. 60, S. 5-46 W. 80 feet to iron pin at back corner of Lot No. 46; thence along the line of said Lot No. 46, N. 89-04 W. 180 feet to iron pin on Wyoming Avenue; thence running with the said Wyoming Avenue, N. 5-46 E. 80 feet to iron pin at point of beginning.

THIS deed is made subject to easement for gas pipe line as is shown on said plat.

THE Grantor reserves to himself, his heirs and assigns, the right and easement to perpetuity to go upon the property herein granted for the right of installing, repairing, maintaining and locating electric power transmission lines.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
