

to the grantor(s) in hand paid at and before the sealing of these presents by the grantce(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES THOMAS COX and MABLE L. COX, their heirs and assigns, forever:

ALL that lot of land with the buildings and improvements thereon situate on the Northwest side of Perry Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 15 on plat of property of Ethel Y. Perry Estate, made September, 1944, by W. J. Riddle, Surveyor, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book B, page 33, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwest side of Perry Road at joint front corner of Lots 14 and 15, and running thence with the line of Lot 14, N. 50-33 W., 105 feet to an iron pin; thence S. 49-20 W., 60.7 feet to an iron pin; thence with the line of Lot 16, S. 50-33 E., 111.4 feet to an iron pin on the Northwest side of Perry Road; thence along the Northwest side of Perry Road, N. 43-30 E., 60 feet to the beginning corner 30 E., 60 feet to the beginning corner.

This is the same property conveyed to me by deed of J. B. Hall and R. E. Cox dated October 14, 1946, and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 300, page 307.

A strip of land across the entire front of this lot 2 feet in depth and approximately 60 feet in width now lies within the boundary of Perry Road, as Perry Road has recently been widened to include such strip.
