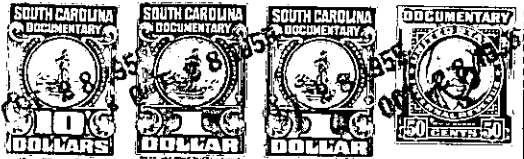
That WE, L. E. SMITH and HAZEL S. WINGARD in the State aforesaid,

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina on the East side of Fifth Avenue, in Section No. 2 of Judson Mills Village, being known and designated as LOT NO. 51 as shown on plat of Section No. 2 of Judson Mills Village made by Dalton & Neves, Engrs., in November 1939, which plat is recorded in the RMC Office for Greenville County in Plat Book "K", at page 25 and having, according to said plat, the following metes and bounds:
