BEGINNING on an iron pin in the center drive running thence South S. 54.30 E. 151 feet to the center of Gap Creek; thence up the creek as the line North 45.15 E. 88 feet to stake in creek; thence N. 50.00 W. 169 feet to an iron pin in the center of River Drive; thence with River Drive as the line S. 34.00 W. 99 feet to a point in said drive, the beginning corner.

The above metes and bounds description was taken from a more recent survey prepared for Herbert E. and Esther T. Rudd by W. P. Morrow, Surveyor, June 1955, and this is the same property conveyed to the grantor herein by Elmar Rich by deed dated July 7, 1955, recorded in aforesaid R. M. C. Office in Volume 529, Page 390.
