

All of that parcel or lot of land in Oneal Township of Greenville County, South Carolina, situated on the South side of the CC Camp Road, near State Highway No. 14 and East therefrom and about 12 miles North from Greer, known and designated as Lot No. 8 on a plat of property made for B.W. Waters by H.S. brockman, Surveyor, dated June 18, 1949, and having the following courses and distances:
