All that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, and having according to a plat prepared by Piedmont Engineering Service dated November 14, 1955, entitled "Property of Franklin Baptist Church" recorded in the R.M.C. Office for Greenville County in Plat Book JJ at page 57, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeastern side of Tremont Street, 108 feet in a Northeasterly direction from the Eastern corner of the intersection of Stafford Street and Tremont Street in the line of property formerly conveyed by the grantor herein to the grantee herein and running thence with the line of said property S. 30-20 E. 50 feet to an iron pin; thence N. 59-46 E. 27 feet to an iron pin; thence S. 30-20 E. 100 feet to an iron pin; thence N. 59-46 E. 50 feet to an iron pin; thence N. 30-20 W. 150 feet to an iron pin on the Southeastern side of Tremont Street; thence with the Southeastern side of Tremont Street S. 59-46 W. 77 feet to the point of beginning.
