All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 7 and the greater portion of Lot No. 6 of a subdivision known as Colonial Estates as shown on plat thereof prepared by Dalton & Neves, Engineers, April, 1951, and recorded in the R.
