

All that lot of land with the buildings and improvements thereon, situate on the Southwest side of Clearview Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 52 on plat of Morningside Subdivision made by Dalton & Neves, Engineers, December, 1952, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book FF at page 85, and having according to said plat and according to a more recent plat prepared by Piedmont Engineering Service dated August 2, 1955, entitled "Property of William H. Alford" the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of Clearview Avenue at joint front corner of Lots 51 and 52 and running thence along the line of Lot 51 S. 54-27 W. 193.5 feet to an iron pin; thence N. 34-25 W. 100 feet to an iron pin; thence with the line of Lot 53 N. 47-29 E. 153 feet to an iron pin on the Southwest side of Clearview Avenue; thence along the Southwest side of Clearview Avenue S. 54-15 E. 125 feet to the beginning corner.
