Stansell Welborn McWhite, his heirs and assigns forever:

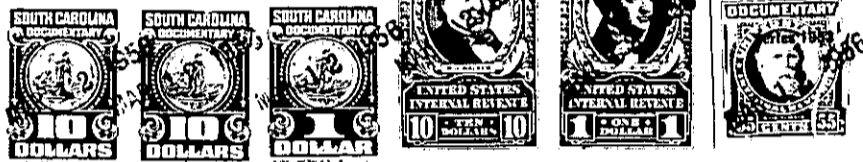

C. in Plat Book "Y", page 147, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Bent Twig Drive at a point 487.2 feet north of the northeasterly corner of the intersection of Bent Twig Drive and Two Notch Road, said pin being the joint front corner of Lots Nos. 20 and 21, and running thence along the easterly side of Bent Twig Drive N 14-46 E 75 feet to an iron pin, joint front corner of Lots Nos. 21 and 22; thence along the joint line of said Lots S 75-14 E 150 feet to an iron pin, joint rear corner of said Lots; thence along the joint line with Lot No. 32 S 14-46 W 75 feet to an iron pin, joint rear corner of Lots Nos. 20 and 21; thence along the joint line of said Lots N 75-14 W 150 feet to the point of beginning.
