

POWER OF ATTORNEY (General)

KNOW ALL MEN BY THESE PRESENTS: That I. A/1C GEORGE E. TRENT a legal resident of the (Town, city or county of) GREENVILLE State of SOUTH CAROLINA United States of America on present United States Air Force duty assignment with 5th AERIAL PORT SQUADRON \_, Neubiberg Air Base, Germany, APO 13, US Air Force, have made, constitute and appoint VIOLA M. , whose address is 109A ROOSEVELT AVE. GRIENVILLE, SC my true and lawful attorney to act in, manage, and conduct all my estate

and all my affairs, and for that purpose for me and in my name, place, and stead, and for my use and benefit, and as my act and deed, to do and execute, or to concur with persons jointly interested with myself therein and things, that is to say:

(1) To buy, receive, lease, accept, or otherwise acquire; to seel, convey, mortgage, hypothecate, pledge, quit claim, or otherwise encumber or dispose of; or to contract or agree for the acquisition, disposel or encumbrance of; any or any custody, possessions, interest, or right therein; or pertaining thereto, upon such terms as my said attorney shall think proper; (2) To take, hold, possess, invest, lease or let, or otherwise manage any or all of my real, personal, or mixed property, or any interest therein; to eject, remove, store, transport, repair, rebuild, modify, or improve the same or any part thereof; (3) To make, do and transact all and every kind of business of what nature or kind soever, including the receipt, recovery, collection, payment, compromise, certlement, and A mistment of all accounts, legacies, brquests, interests, dividends, annuities, demande, debts, taxes, and obligations which may now or hereafter be due, owing, or payable by me or to me; (4) To make, indorse, accept, recieve, sign, seal, execute, acknowledge, and deliver deeds, bonds, vouchers, receipts, and such other instruments in writing of whatever kind and nature as may be necessary, convenient, or proper in the premises; (5) To deposit and withdraw for the purposes hereof, in either my said attorney's name or my name or jointly in both our names, in or from any banking institution, any funds, regotiable paper, or monies, which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit or be entitled to; (6) To institute, prosecute, defend, compromise, arbitrate, and dispose of legal, equitable, or administrative hearings, actions, suits, attachments, arrests, distresses, or other proceedings, or otherwise engage in litigation in connection with the premises: (7) To act as my attorney or proxy in respect to any stocks, shares, bonds, or other impestments, rights, or interests I may now, or hereafter, hold: (8) To engage and and record dismiss agents, counsel, and employees, and to appoint and remove at pleasure any ambatitute for, or agent of my said attorney, in respect to all or any of the matters, and things herein mentioned and upon such terms as my attorney shall think fit; (9) To execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law or US Air Force regulations, and to receive, indorse, and collect the proceeds of checks payable to the order of the undersigned drawn on the Treasurer of the United States; (10) To prepare, execute, and file income and other tax returns and other governmental reports, applications, requests and documents; (11) To take possession, and order the removal and shipment of any of my property from any post, warehouse, depot, dock, or other place of storage or safekeeping, governmental or private; and to execute and deliver any release. voucher, receipt, shipping ticket, certificate or other instrument necessary or convenient for such purpose.
