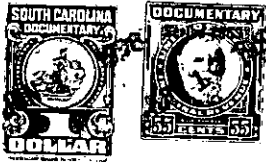

Know All Men by These Presents:

That JOHN RICHARD DAVIS in consideration of the sum of FIVE HUNDRED AND NO/100 DOLLARS, and assumption of mortgage described below; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

JOE A. PANNELL, his heirs and assigns:

All that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 11, Section One, Oak-Crest, as per plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "GG", pages 110-111, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a pin on the Southerly side of Welcome Avenue, joint front corner Lots 10 and 11, and running thence with the Southerly side of Welcome Avenue, N. 60-02 E. 70 feet to a pin at the corner of Lot 12; thence along the line of Lot 12, S. 29-58 E. 150 feet to a pin at rear corner of Lot 26; thence along the rear line of Lot 26, S. 60-02 W. 70 feet to a pin at the rear corner of Lot 10; thence along the line of Lot 10, N. 29-58 W. 150 feet to the beginning corner.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given First Federal Savings and Loan Association; said mortgage being recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgages Volume 642, page 303.
