to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Guy W. Strickland, his heirs and assigns, forever:

All those two lots of land in Chick Springs Township, County of Greenville, State of South Carolina, known as Lots Nos. 19 and 20 of Block "C" on plat of Buena Vista, and recorded in the R. M. C. Office for Greenville County in Plat Book "W" at Page 11; and having according to said plat the following metes and bounds, to wit:

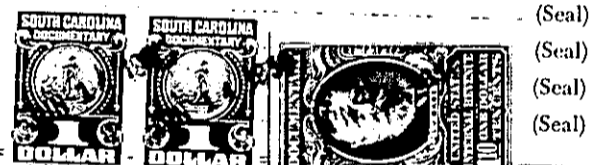
