One Thousand Eight Hundred Thirty-to me in hand paid at and before the sealing of these presents by THE CITY OF GREENVILLE, SOUTH CAROLINA (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, forever:

ALL those pieces, parcels or tracts of land, with all improvements thereon, situate, lying and being in Saluda Township, in Greenville . County, State of South Carolina, located in the Lazy City Subdivision, and being more particularly described as follows:

LOT No. 4, Section 6, of Lazy City, according to a plat thereof recorded in the RMC Office for Greenville County, S. C., in Plat Book "BB", page 46, and being the same property conveyed to the Grantor herein by deed of Lazy City, Inc., dated September 4, 1952, recorded in the RMC Office for Greenville County, S.
