Know All Men by These Presents:

That I, John K. Temple, Jr., in the State aforesaid, in consideration of the sum of Six Hundred (\$600.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Leroy Gunter, his heirs and assigns forever:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being shown and designated as Lot No. 14 on the northern side of Redwood Drive, as shown on a plat of Subdivision No. 1 of the property of W. H. Hendrix, prepared by Dalton & Neves in December, 1953, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book III at page 41.

Subject to the following restrictions:

- (1) All of said lots shall be used for residential purposes only.
- (2) No residence shall be constructed on any of said lots having an area of less than 1,000 square feet exclusive of porches.
- (3) No house or structure shall be built with exposed cement blocks.
- (4) The building line as shown on said plat shall be adhered to.
- (5) No trailer, basement, tent, shack, garage, barn or other outbuilding erected in the tract shall at any time be used as a residence temporarily or permanently nor shall any structure of a temporary nature be used as a residence.
- (6) These restrictions shall run with the land, and shall be binding upon all parties and all parties claiming under them until January 1, 1975.
- (7) If any owner of any lot shall violate or attempt to violate any of the restrictions herein, any other person or persons owning any real estate in said subdivision may prosecute any proceedings at law or in equity, to prevent such violation or recover damages for such violation.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
