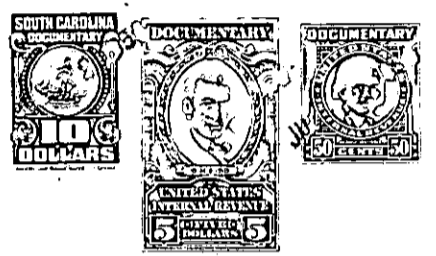

ALL that piece, parcel or tract of land with all buildings and improvements thereon, situate, lying and being in Saluda Township, in Greenville County, State of South Carolina, located on the North side of U. S. Highway No. 25, at Camp Onawa, and having the following description:

BEGINNING at the Cora Hawkins corner and running thence N. 34 W., 18 poles to a stake; thence S. 65 W., 6 poles and 7 links to a stake; thence S. 33 E., 19 poles and 20 links to a point on the Greenville-Hendersonville Highway; thence with said Highway, N. 55 E., 4 poles to the beginning corner.
