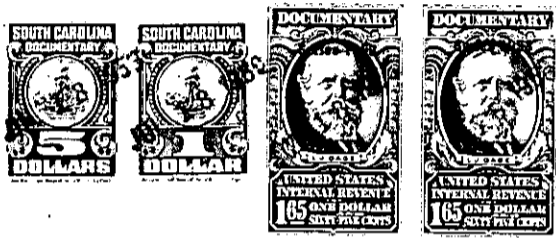
Know All Men by These Presents:

All that piece, parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as a portion of Tract No. 3 of the B. F. Flynn Estate as shown on plat of same recorded in the R.M.C.
