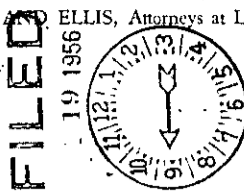

That certain lot of land, with improvements thereon, in Highland Township, School District #385, said County and State, and on the southeast side of State Highway #414, and described as follows:

Beginning at a point in the center of Highway #414 at point of the crossing of the old Tugaloo Road, and runs thence with said Highway to a point on line of the Tiger Church lot in the center of said Highway; thence with the Church line and the Stroud line to a point in the old Tugaloo Road; thence with the said road as the line to the beginning corner, and conveyed to us by Virgil Heath on June 2nd, 1956, and recorded in R.M.C.office, Vol. 554 page 361.
