All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, being known and designated as Lot Number Two (2), as shown on plat of property of Morningside, as made by Dalton & Neves, Engineers, in December 1952, which plat is of record in the R. M. C. Office for said County and State in Plat Book "EE", at pages 2 and 3, reference to which plat is hereby made, said lot of land being described by metes and bounds, as follows, to-wit:

BEGINNING at an iron pin on the Northeastern side of Spring Valley Road as shown on said plat at the corner common to Lots 2 and 3, and running thence North 43-30 East along the dividing line between Lots 2 and 3, one hundred ninety-one and two-tenths (191.2) feet to an iron pin at the corner of Lot 21; thence North 46-30 West along the dividing line between Lots 2 and 21, one hundred twenty-five (125) feet to an iron pin; thence South 43-30 West, one hundred ninety-three and eight-tenths (193.8) feet to an iron pin on the Northeastern side of Spring Valley Road; thence South 47-45 East along said Spring Valley Road, one hundred twenty-five (125) feet to the place of beginning.
