ALL that certain piece, parcel or tract of land in Paris Mountain Township, Green-ville County, State of South Carolina, adjoining lands of Pete Marchbanks, Allen Wright, J. E. Seaborn, Queen Burns, and other lands of Jonas Bishop, and being located about 9 miles from Greenville County Courthouse, and being shown as a portion of tract no. 1, and containing 3.57 acres, more or less, according to a plat of the property of Jonas Bishop as prepared by Woodward Engineering So., Greenville, S. C., August, 1953, and as revised December, 1954, and having, according to said revised plat, the following metes and bounds, to-wit:

Seaborn property; thence with the line of said property, N. 61-00 E., 3.03 chs., to iron pin, corner of Allen Wright property; thence with line of Allen Wright property, N. 32-30 W., 6.14 chs. to an iron pin; thence with the line of property of Pete Marchbanks, N. 43-00 W., 7.71 chs. to iron pin on Little Texas Road, the point of beginning.
