

All that lot of land in Austin Township, Greenville County, State of South Carolina located on the south side of North Pliney Circle, in the Town of Simpsonville, known and designated as lot 62 of the sub-division known as League Estates, according to a plat made by W. J. Riddle, Surveyor, in October 1941, said plat being recorded in the R.M.C. Office for Greenville County in Plat Book K at pages 111 and 112, and more particularly described as follows:

Beginning at a pin at the southwest corner of the intersection of North Pliney Circle and North Church Street, and running thence along the west side of North Church Street S 19 E, 200 feet to corner of lot 49; thence with rear line of lot 49, S 70-15 W, 89.6 feet to corner of lot 63; thence with line of lot 63, N 19-45 W, 200 feet to pin on south side of North Pliney Circle; thence along the south side of said circle N 70-15 E, 90.5 feet to the beginning corner.
