Weaver, her heirs and assigns forever:

All that piece, parcel or lot of land in O' Heal Township, County of Greenville, State of South Carolina, located four mile North From Greer, S. C., and lying on the North side of the Gap Creek Road, and being known as tracts FOUR (4), FIVE (5) and SIX (6) on a plat of property made for Caswell L. Cooper by H. S. Brockman, surveyor, dated Feb. 9, 1957 and recorded in plat book EE page 193, Greenville County R. M. C. Office and having the following metes and bounds, according to said plat.
