


ALL that certain lot or parcel of land situate, lying and being in the City of Greenville, County and State aforesaid, on the North side of Harcourt and being known and designated as Lot No. 11 as shown on a plat of Harcourt, recorded in the R.M.C. Office for Greenville County in Plat Book F, Page 284, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pipe on the North side of Harcourt (204.3 East of Bennett Street), joint corner of Lots Nos. 11 and 12, and running thence with joint line of said lots N. 17-58 E. 149.4 feet to an iron pipe; thence S. 72-02 E. 68 feet to an iron pipe, joint corner of Lots 10 and 11; thence along the joint line of said lots, S. 17-58 W. 149.4 feet to an iron pipe on Harcourt; thence with said Harcourt, N. 72-02 W. 68 feet to the point of beginning.
