

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said McAdams Christopher, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being in O'Neal Township, Greenville County, South Carolina, on the south side of Beaverdam Creek, waters of Enoree River, known as part of the Lemual C. Dill land as devised to him by Elijah Dill and devised to Elizabeth Dill Brookshire by Lemual C. Dill, bounded by W. R. C. Edwards, "Carp" Edwards, Estate of J. J. McSwain, et al, and having the following metes and bounds, to-wit:
