Know All Men by These Presents:

That I, John H. Greer, in the State aforesaid, in consideration of the sum of Nine Hundred (\$900.00) DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wilson M. Dillard and his heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, State of South Carolina, located about one mile southwest of the City of Greer and on the northwest side of the Hammett Bridge Road, near Pleasant Grove Baptist Church, being the northeastern portion of Lot No. 7 as shown on a plat of property made for John H. Greer by W.P. Morrow, dated July 2, 1955, and having the following courses and distances, to-wit: BEGINNING on an iron pin in the Hammett Bridge Road, joint corner of Lots Nos. 6 and 7 on said plat, and runs thence N. 44-30 W. 200 feet to an iron pin; thence S. 42-24 W. 75 feet to a point, new corner; thence a new line, S. 44-30 E. 200 feet to a point in the Hammett Bridge Road; thence N. 42-12 E. 75 feet to the beginning corner.

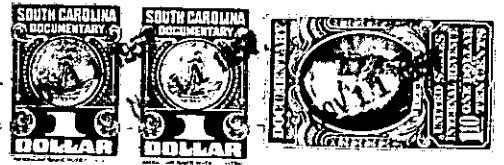
This property shall be used for residential purposes only, and no dwelling house shall be erected on said lot with less than 1150 square feet floor space, not including porches and stoops, and valued at not less than \$9,000.00. A septic tank shall be required for each dwelling and no outbuildings shall be erected, except a garage. No livestock shall be kept upon the premises.

These restrictions are for the benefit of the Grantor herein and his heirs or devisees, and also for the benefit of any others who may purchase lots out of this subdivision, and should there be a violation of these restrictions any of the same may seek injunctive relief and damages.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
