

All that piece, parcel or lot of land in Paris Mountain Township. Greenville County, State of South Carolina, being known and designated as the South 35 feet of Lot No. 2 as shown on plat of property of the grantor recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "B", at page 141, and also a part of the Northern portion of Lot No. 1 as shown on said plat, and being more particularly described as follows:

BEGINNING at a stake on the West side of North Parker Road (formerly known as Poor House Road) at Southereast corner of lot this day conveyed to Joe Manning Snyder, and running thence with his line in a westerly direction 660 feet more or less to a stake in branch; thence down and with the center line of said branch 165 feet to a stake; thence in an Easterly direction 700 feet more or less to a stake on the West side of said Road, which stake is 117 feet South of an iron pin, joint front original corners of Lots Nos. 1 and 2; thence with said Road, N. 4-45 E. 152 feet to the beginning.

C. in Deed Book156, at page 30; and being the same property conveyed to us by James E. Snyder by deed dated April 12, 1951 and recorded in the R. M. C. Office for Greenville County in Book 432, at page 392.
