

M. W. Fore, his Heirs and Assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Caroline, being known and designated as lot 466, Section, D., Englewood Estates, as shown by a plat thereof, dated February 1955, recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at page 177, and having the following metes and bounds, to wit:

BEGINNINT at an iron pin on the northwest side of Burmaster Drive, joint front corners of lots 465 and 466 and running N. 86-43 W. 75 feet to an iron pin, joint front corners of lots 466 and 467; thence along the line of lots 466 and 467 N. 3-15 E. 278.7 feet to an iron pin, joint rear corners of lots 467 and 466; thence with the rear line of lot 466 S. 88-0 E. 75.02 feet to an iron pin, joint rear corners of lots 466 and 465; thence along the line of lots 466 and 465 S. 3-15 W. 280.4 feet to an iron pin on Burmaster Drive, the point of beginning.

Restrictions: Said property is not to be sold, rented or otherwise disposed of to any Negro or person of African descent; no residence shall cost less than \$8,500.00; no residence shall be erected on said lot nearer than 50 feet to the front line; and no residence shall be erected on any lot unless it have 50 feet or more frontage. No outside toilets are permitted. Sewage must be disposed of by approved septic tanks.

GRANTEE herein to pay taxes for the year 1957.

This deed is subject to any rights of way now existing.
