

BEGINNING at an iron pin on the easterly side of Rockmont Road, joint corner Lots 143 and 144; and running thence along Rockmont Road S. 6-10 W. 120 feet to an iron pin; thence around the curve of the intersection of Rockmont Road and old Spartanburg Road, the chord of which is S. 44-17 E. 32 feet to an iron pin on Old Spartanburg Road; thence along Old Spartanburg Road N. 85-24 E. 158.3 feet to an iron pin; thence N. 3-40 W. 70 feet to an iron pin; thence N. 2-06 E. 51 feet to an iron pin; thence along the line of Lot 144 N. 86-59 W. 164.6 feet to an iron pin to the point of beginning. This property is located in the northeast intersection of Rockmont Road and Old Spartanburg Road.


