

All that certain piece, parcel or tract of land with the buildings and improvements thereon situate, lying and being on the East side of a County Road in Austin Township, County of Greenville, State of South Carolina containing 38 acres, more or less, being shown and designated as the northern portion of Tract No. 3 on Map No. 2, Property of Nannie C. Fowler, prepared by W. J. Riddle, Surveyor, dated May, 1947, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", at pages 124 and 125, and having according to said

King; thence along the line of King, N. 83-25 E. 783 feet to a point; thence continuing with the line of King, due East 1085 feet to a point in line of Tracts 2 and 3; thence along the line of Tract No. 3, N. 32-00 W. 155 feet to a point in branch; thence continuing along the line of Tract No. 3, N. 10-30 W. 306 feet to a point; thence still with the line of Tract No. 3, N. 54-45 W. 234 feet to a point; thence still with the line of Tract No. 3, N. 33-15 W. 411 feet to a point; thence continuing with the line of Tract No. 3, N. 24-30 W. 448 feet to a point at corner of Tracts 1 and 3, said point being in the center of a County road; thence with the line of Tract No. 3 and the center of said road S. 34-00 W. 200 feet to a point; thence continuing with the line of Tract 3 and center of said road, S. 47-30 W. 199 feet to a point; thence still with said Tract 3 and center of said road, S. 30-45 W. 110 feet to a point in the intersection of two county roads; thence continuing with the line of Tract 3 and the center of said County road, N. 87-00 W. 599 feet to a point in line of property now or formerly of Roy F.
