Lessee shall notify Lessor in writing of its election to extend said lease at least sixty (60) days prior to the date of the expiration of the term of said lease, and notice from Lessee to Lessor shall be sufficient if delivered to Lessor or if by telegram, or if placed in the United States Mails addressed to Lessor at the address shown hereinabove.

Except as hereby modified, changed and amended, said lease hereinabove described shall be and remain the full agreement of the parties, according to its original tenor and effect.
