All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina at the intersection of Boxwood Lane and Woodland Way and being known and designated as Lot Number 6 of Boxwood Manor, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book BB at Page 35 and having, according to a more recent plat made by Piedmont Engineering Service, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Woodland Way at the joint front corners of Lots 5 and 6 of said subdivision and running thence along the common line of said lots N. 29-08 W. 250 feet to an iron pin; thence along the common line of Lots Numbers 6 and 18 S. 60-52 W. 100 feet to an iron pin on the Eastern side of Boxwood Lane; thence along the Eastern side of Boxwood Lane S. 29-08 E. 200 feet to a point; thence following the curve of Boxwood Lane as it converges with Woodland Way, the chord of which curve runs S. 74-08 E. 70.7 feet to a point on the Northwestern side of Woodland Way; thence along the Northwest side of Woodland Way N. 60-52 E. 50 feet to an iron pin, the beginning corner, being the same property conveyed to the Grantor herein by Richard H. Butler and Sue A. Butler by deed dated December 22, 1954 and of record in the R. M. C. Office for Greenville County in Deed Book 514 at Page 437.
