to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

SADIE POSLEY and DAVID POSLEY, their heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, Gantt Township, Greenville County, South Carolina, on the Northern side of Davis Circle running West from the Old Augusta Road, being a portion of Tract # 4 of the Estate of Ella Easley according to a plat thereof prepared by R. E. Dalton, February 1923, and having the following metes and bounds, to-wit:

BEGINNING at a stake on the Northern side of Davis Circle, said stake being 42 feet West of the Southwestern corner of property of Willie E. Burton, and running thence along said Circle S. 57-35 W. 125 feet to a stake; thence in a Northwestern direction 80 feet to a stake on the line of Yancey Carter Property; thence along said Carter line N. 57-35 E. 125 feet to a stake; thence in a Southeastern direction 80 feet to the point of beginning.
