

Know All Men by These Presentse,

That I, Connie Jane Whitfield in consideration of the sum of one thousand dollars (\$1000.00)

in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantees, Floyd H. Wilson and Margaret W. Wilson, their heirs and assigns forever:

All of that certain piece, parcel or lot of land in Greenville Township, Greenville County, S. C., being known and designated as the rear portion of Lot No. 55 as shown on plat of Parker Heights recorded in the R. M. C. Office for Greenville County in Plat Book P, at page 43 and having the following metes and bounds:

BEGINNING at an iron pin at the joint rear corner of Lots 55 and 56, said iron pin being 150 feet from the joint front corner of Lots Nos. 55 and 56 on Calhoun Street; running thence S. 30-45 W. 50 feet to an iron pin, joint rear corner of Lots Nos. 55 and 54; running thence N. 59-15 W. 75 feet to an iron pin, a new pin; running thence N. 30-45 E. 50 feet to an iron pin; running thence along the joint line of Lots 55 and 56, S. 59-15 E. 75 feet to the point of beginning.

Together with the easement and right-of-way over and across the front portion of Lot 55 for the purpose of ingress and egress which is to run with the land. Said easement and right-of-way being a 10 foot strip along the boundary line of Lots 55 and 56 from Calhoun Avenue to the lot above described and being 10 feet in width and running back in parallel lines to a depth of 75 feet to the line of the property heretofore described. Together with the right of the grantees, their heirs and assigns to use the water from the well situated on the front part of Lot 55. The grantor however is not to be responsible for the maintenance of the well and is not to be responsible if the well fails to produce water and this easement or right-of-way is to run with the land.
