in consideration of the sum of Eighteen Thousand and No/100 (\$18,000.00)-----DOLLARS,

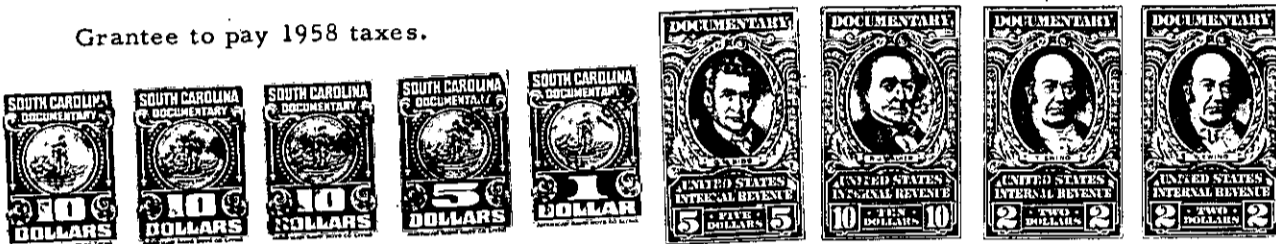
in the State aforesaid,

All that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying, and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 2, on plat of property of W. W. Pruitt, made by C. C. Jones, Engineer, October 1957, and having, according to said plat, and according to plat of property of James Marvin Farmer and Shirley P. Farmer, which plat is recorded in the RMC Office for Greenville County, in Plat Book PP, page 33, the following metes and bounds, to wit:
