do grant, bargain, sell and release unto the said GEORGE T. BEATTIE his heirs and assigns

All that certain piece, parcel or lot of land situate, lying and being on the South side of Ridgeland Avenue, in the City of Greenville, County of Greenville, State of South Carolina, known as the Eastern 30 feet of Lot No. 9 on plat of Cleveland Terrace, made by Dalton & Neves, Engineers, February, 1926, recorded in the R. M. C. Office for Greenville County in Plat Book G, at page 210, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Ridgeland Avenue, at joint front corner of Lots Nos. 9 and 10, and running thence with the line of Lot 10, S. 23-33 W. 206.4 feet to an iron pin on the North side of a 15-foot alley; thence with said alley N. 69-18 W. 30 feet to an iron pin in the rear line of Lot No. 9; thence running through Lot No. 9 N. 23-33 E. 208 feet to an iron pin on the South side of Ridgeland Avenue; thence with the South side of Ridgeland Avenue S. 66-17 E. 30 feet to the beginning corner.

ALSO; All that certain piece, parcel or lot of land situate and being on the South side of Ridgeland Avenue, in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot 10 of Cleveland Terrace, as shown on plat made by Dalton & Neves, Engineers, 1926, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book G, page 210, and having, according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Ridgeland Avenue, which iron pin is 120 feet East from the Southeast corner of the intersection of McDaniel and Ridgeland Avenues, and running thence along the South side of Ridgeland Avenue, S. 63-33 E. 70 feet to an iron pin, joint corner of Lots 10 and 11; thence with the joint line of said lots S. 23-33 W. 199.7 feet to an iron pin on the North side of a 15-foot alley; thence along the North side of said alley N. 69-18 W. 70 feet to an iron pin, joint rear corner of Lots 9 and 10; thence with the joint line of last mentioned lots N. 23-33 E. 206.4 feet to an iron pin on the South side of Ridgeland Avenue, the point of beginning.

This is the identical property conveyed to the Grantor herein by deed of George Kirkwood King dated December 29, 1949 and recorded in the R. M. C. Office for Greenville County, South Carolina in Deed Book 399 at page 32.
