Weston Street, known and designated as Lot No. 2 of the lands of L. R. Gault, with the following metes and bounds, to-wit: Beginning at an iron pin on the North side of N. Weston Street, joint front corner with Lot No. 1 this day conveyed to Samuel L. Gault, and running thence with said N.
