

C., in Plat Book KK, page 85, and according to said plat, having the following metes and bounds, to-wit: BEGINNING at an iron pin on the Southern side of Everest Street, at the joint front corner of Lots Nos. 17 and 18, and running thence along the joint line, S. 4-40 W. 175 feet to an iron pin; thence Si. 85-25 E. 126.5 feet to an iron pin on the Western side of Pinnacle Drive and running thence along the Western side of said Drive, N. 9-29 W. 155.5 feet to an iron pin at the intersection of Pinnacle Drive with Everest Street, which intersection is curved, the chord of which is N. 33-15 W. 39.4 feet to an iron pin on the Southern side of Everest Street; thence with the Southern side of Everest Street, N. 85-20 W. 58.2 feet to an iron pin, the point of beginning.
