

BEGINNING at an iron pin on the Northern side of a five foot sidewalk running along McMakin Drive, at the joint front corner-of Lots Nos. 97 and 98 on said plat and running thence along McMakin Drive, N. 79-28 E. 25 feet to point in center of Lot No. 98; thence through the center of said lot, N. 10-17 W. 150 feet to point; thence S. 79-28 W. 25 feet to point at corner of Lot No. 97; thence along the line of Lot No. 97, S. 10-17 E. 150 feet to beginning corner.

BEGINNING at an iron pin on the Northern side of McMakin Drive, joint Southern corner of Lots Nos. 97 and 98, and running thence along the dividing line of said Lots, N. 10-17 W. 150 feet to an iron pin, joint Northern corner of Lots Nos. 97 and 98; thence S. 79-28 W. 75 feet to an iron pin; thence S. 10-17 E. 150 feet to an iron pin; thence N. 79-28 E. 75 feet to the point of beginning.
