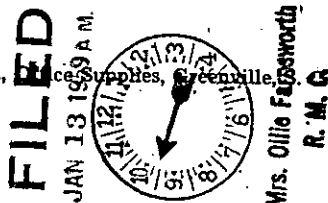

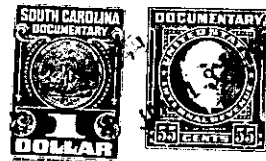
Know All Men by These Presents:

Fore in the State aforesaid, in consideration of the sum of Four Hundred Ninety Five & NO/100 (\$495.00) - - - -DOLLARS, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipts whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. N. Reid, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, near Cleveland, South Carolina, being known, and designated as Lot No. 29, Range Trail of a subdivision known as Wonderland Range as shown on a Plat recorded in the R. M. C. Office for Greenville County in Plat Book BB, at Page 29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Range Trail joint front corners of Lots Nos. 28 and 29 and running thence along the line of said lots, S. 54-26 W. 133 feet to iron pin rear corner of Lots 28A and 29A; thence running with rear line of Lot 29A, N. 31-00 W. 116 feet to iron pin rear corner of Lot 30; thence running with line of said lot, N. 54-26 E. 165 feet to iron pin on Target Hill Road; Thence running with Said Road, S. 30-41 E. 116.8 more or less to iron pin; thence running S. 27-19 W. 37.2 feet to iron pin at point of beginning.

IT is understood and agreed that this conveyance is made subject to restrictions recorded in the R. M. C. Office for Greenville covering said property. Also Right-of-way and all other recorded instruments.
