EASEMENT

THIS INDENTURE, made this 2 3 day of ang, 19 5 3
by Henry Scott , hereinafter referred to as the Landowner,
and . Greenville Soil Conservation District hereinafter referred to as the Local Organization,
WITNESSETH THAT: .
WHEREAS, the Secretary of Agriculture, United States Department of Agriculture, is authorized by the Watershed Protection and Flood Prevention Act to carry out a program of assistance to local organizations in planning and installing works of improvement for flood prevention or the conservation, development, utilization and disposal of water, and
WHEREAS, the Local Organization is cooperating in said program for the purpose of installing a project in
the <u>Huff Creek</u> watershed, State of South Carolina, in connection with which it desires to secure certain rights in, over and upon the hereinafter described land of the Landowners,
THEREFORE, for and in consideration of One Dollar (\$1.00) and the benefits accruing to the Landowner from the installation of said project, and other good and valuable considerations, the receipt whereof is hereby acknowledged, the Landowner does hereby grant, bargain, sell, convey and release unto the Local Organization an ease-
ment in, over and upon the following described land situated in the County of
The flood retarding structure No. LC covered by this easement will be located above the deep cut on the headwaters of Huff Creek. The 1.6 acres that will be in the Flood Pool, covered by this easement is also located on the headwaters of Huff Creek. The area in structure LC and the 1.6 acres in the Flood Pool is a portion of the tract of land conveyed by Stella C. Harris to Henry Scott by deed and recorded in Book of Deeds, Vol. III. Page 254, located in R. M. C. office in Greenville County, South Carolina. A more detailed description of the acreage involved is shown in a sketch map designated as flood retarding structure No. LC Huff Creek watershed, filed in Plat Book EE, Page 114, in the office of R. M. C. in Greenville County, South Carolina.

The District shall have the right, privilige, and authority to overflow, flood, and store water impounded by the above proposed flood retarding structure. The District shall have the right, privilige and at authority to construct Flood Retarding Structure No. 4C, and storm spillway approximately 400 ft. wide. The barrow pit or pits will be located in an area close to the structure. The right to use the barrow areas is granted the district. The right to permit overflow of spillway over area below dam is granted.

1. The Local Organization shall be responsible for operating, maintaining, and keeping in good repair the works of improvement herein described.

- 3. This easement shall include the right of ingress and egress at any time over and upon said land any adjoining land owned by the Landowner for construction, inspection and maintenance.
- 4. The easement herein conveyed shall be subject to any easements, rights-of-way, or mineral reservations or rights now outstanding in third persons.
- 5. The Landowner hereby releases the Local Organization from any and all claims from damages to the herein described lands or adjoining lands of the Landowner resulting from the installation of works of improvement herein described.

^{2.} The Landowner reserves the right to use said land or any part thereof at any time and for any purpose, provided such use does not interfere with the full enjoyment by the Local Organization of the easement herein conveyed.
